PRODUCT DESCRIPTION AND BASIC USE

WOODguard[®] SWO is a clear, water repellent that helps retard warping, cupping, splitting and nail popping. Especially designed for pressure-treated lumber. Restores lubricity lost in wood during pressure treatment. Will never crack or peel.

WOODguard SWO is a colorless, water-repellent treatment for pressure-treated wood. Pressure treatment effectively preserves wood against insect attack and degradation from mold and fungal growths. It is not, however, immune from the damaging effects of water. Pressure treatment causes wood to become highly porous and water absorbent. In winter, water will freeze in the pores of the wood cell structure and then thaw, eventually causing the wood to become brittle. Direct sun and heat of summer further dry the wood, which eventually warps and splits long before it ever rots from decay.

FEATURES

WOODguard SWO is absorbed into the wood and bonds with the cell structure. The oils lubricate and stabilize the wood while repelling water. It helps retard warping, cupping, splitting and nail popping. One moderate coat promotes dimensional stability, and special penetrating oils restore the natural lubricity of the wood often lost in the pressure-treating process. Woodguard SWO is recommended for use on pressure treated wood decks, fences, storage buildings and all other pressure-treated wood construction projects.

COLOR

WOODguard SWO dries into the wood and does not provide any color. Application of WOODguard SWO will give wood an oiled appearance which weathers out to a silvery grey color over time. Most alkyd/oil-based stains can be applied over WOODguard SWO after two weeks minimum cure period. It is best to apply this dual treatment first to a small, remote surface in order to verify compatibility. Do not attempt to apply latex finishes/stains over WOODguard SWO. **DO NOT TINT!**

APPLICATION

WOODguard SWO is easy to use. It can be brushed, rolled or sprayed. Apply above 50° F for fastest cure time. (Below 50° F, WOODguard SWO may become too viscous to spray). One moderate coat is sufficient. Do not over apply. Use only as much as can be readily absorbed by the wood. Surfaces should be cleaned and free of all loose debris. When using wood that has not been kiln dried, wait six months after construction before treating for maximum penetration. Moisture content of wood should be less than 18%.

SUBSEQUENT TREATMENTS

WOODquard SWO can be re-applied when the surface exhibits signs of water absorption.

COVERAGE

250 - 300 sq. ft/gal depending on surface condition and wood porosity.
